## PARTICIPANTS -EXHIBITORS

### 1. INSTALLATION CONDITIONS

The exhibitor must beforehand fill in and sign the form «EXHIBITION REGISTRATION FORM " contained in this folder, and pay all costs associated with his participation in the fair.

### 2. PAYMENT METHOD:

Exhibitors can pay their participation in cash, by cheque as follows:

100% at the time of the booking before October 15, 2016

### 3. WITHDRAWAL:

In case of withdrawal or non-occupation of the stand for any reason, the sums paid for the reservation are not reimbursable.

### 4. ACCESS TO THE FAIR:

Badge: The EXHIBITOR badge must be worn.

The exhibitor badges and service will be collected with the organizer 10 days before the event.

### 5. DATE OF INSTALLATION AND DISMANTLING OF STANDS:

Period of Installation:

**TURNKEY STAND: October 30, 2016 before 5 PM**

**Installation:** Stands must be entirely completed, the exhibited and displayed products before the official opening of the fair.

**Dismantling:** The removal of exhibited products and facilities will be done on November 2, 2016 from 4 PM

### 6. CLEANING, KEEPING AND GUARDING:

The general cleaning of the passageways of the fair, the guarding of the premises are carried out outside the opening hours.

### 7. CHANGE OF LOCATION:

The Management reserves the right to bring new provisions or modify these provisions in the interest of the fair.

By signing this participation request, exhibitors undertake to ensure the provisions of this regulation and new instructions that could be imposed by circumstances.

Failure to comply with this regulation will expose his author to immediate, temporary or permanent exclusion without being entitled to claim any reimbursement or compensation.

**8. INVITATIONS:**

Invitations must not be reproduced or resold under threat of prosecution and punishment.

As such, the organizer reserves the right to neutralize the invitation cards which fraudulent use (resale, reproduction, theft ...) would have been brought to his attention.

**9. PRISE DE VUE/MARQUE :**

The exhibitor expressly authorizes for free, the organizer and its subsidiary companies:

Failure to comply with these provisions may result, without notice, in cutting off the electricity of the stand of the exhibitor without the latter being able to claim any compensation from the organizer.

**11. ADVERTISEMENT:**

Any light or sound advertising should be subject to the organizer's prior written approval. This approval will remain subject to the condition that the advertising does not represent in any way a nuisance to neighboring exhibitors, to circulation and, in general, the good performance of the fair, otherwise the approval may be withdrawn .

**12. PRODUCTS AND SERVICES SAFETY:**

The exhibitors certify that the products or services comply with the safety standards imposed by the regulations in force and assume all responsibility of possible defects of such products or services without the organizer's liability being sought.

**13. WAIVER OF CLAIMS:**

The organizer is not responsible for damage that the exhibitors may cause to third parties nor losses, thefts or materials destruction and goods they exhibit.

Every exhibitor, through his/her participation, declares that he waives all recourses that himself or his insurers would be entitled to exercise against the organizer.
